

## Organizer

1. The Draw (as defined below) is organized by Luminor Bank AS, acting in the Republic of Lithuania through Luminor Bank AS Lithuanian Branch, branch code: 304870069, address: Konstitucijos ave. 21A, 03601 Vilnius, Lithuania (hereinafter – Luminor Bank).
2. With these Terms and Conditions (hereinafter – the Terms), Luminor Bank sets out the procedure and the rules for organizing the Draw. All registered participants must follow these Terms.

## Duration

3. The campaign “Renew your consent and win!” will take place from 23<sup>rd</sup> of September 2024 until 15<sup>th</sup> of December 2024 (inclusive) – this is the period when the participants may register and fulfil the conditions of the Draw specified herein to be eligible to win the Prize (as defined below).

Total of 12 draws will take place on the following dates:

- 2<sup>nd</sup> of October 2024, 9<sup>th</sup> of October 2024, 16<sup>th</sup> of October 2024, 23<sup>rd</sup> of October 2024, 30<sup>th</sup> of October 2024.
- 6<sup>th</sup> of November 2024, 13<sup>th</sup> of November 2024, 20<sup>th</sup> of November 2024, 27<sup>th</sup> of November 2024.
- 4<sup>th</sup> of December 2024, 11<sup>th</sup> of December 2024, 18<sup>th</sup> of December 2024.

## Participants

4. The Draws are open for all eligible participants who, on the date of the registration, are residents of Republic of Lithuania and over 18 years old.
5. Employees of Luminor Group are not eligible to participate in the Draws.
6. To be eligible to participate in the Draws, the participant must register by renewing their consent in one of the following ways:
  - By filling out the form on [Marketing Consents | Luminor](#).
  - By logging on their internet bank and renewing their consents in the settings page (see instructions at the bottom).
  - By renewing their consents while on-call with a Luminor customer representative.

Everyone who has renewed their consents within the campaign period, will participate in every Draw, unless they have already won.

7. Only one registration is needed to be eligible to win in one of the draws. For instance, the participant who renewed their consent in October, is automatically eligible for the Draws in November as well.

## The prize

9. Names of the winners will be published on [Marketing Consents | Luminor](#) and Luminor will reach out to every winner within 2 business days by calling them. If Luminor fails to reach the winner within 10

business days after the Draw and agree on which prize the winner chooses, the prize will remain in Luminor possession.

10. To eliminate waste, the prize will be sent to the winner via e-mail within 30 days of the Draw. If the winner wants to receive the prize in Luminor office or by mail, it can be arranged upon request, but might not be done within the 30-day limit.

### **Miscellaneous**

The winner of each Draw will be announced no later than by the 3rd working day of the following week. The Prize winners will be notified in person by calling or sending an email or message to the email address or telephone number provided to Luminor Bank.

17. The participant has the right to withdraw from the Draw at any time or to refuse to accept the Prize, by submitting a written request to Luminor Bank.

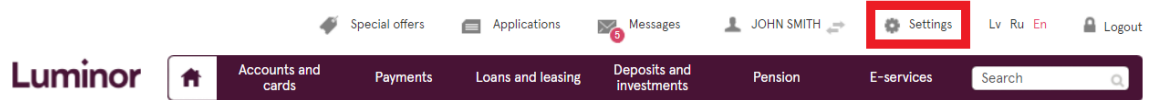

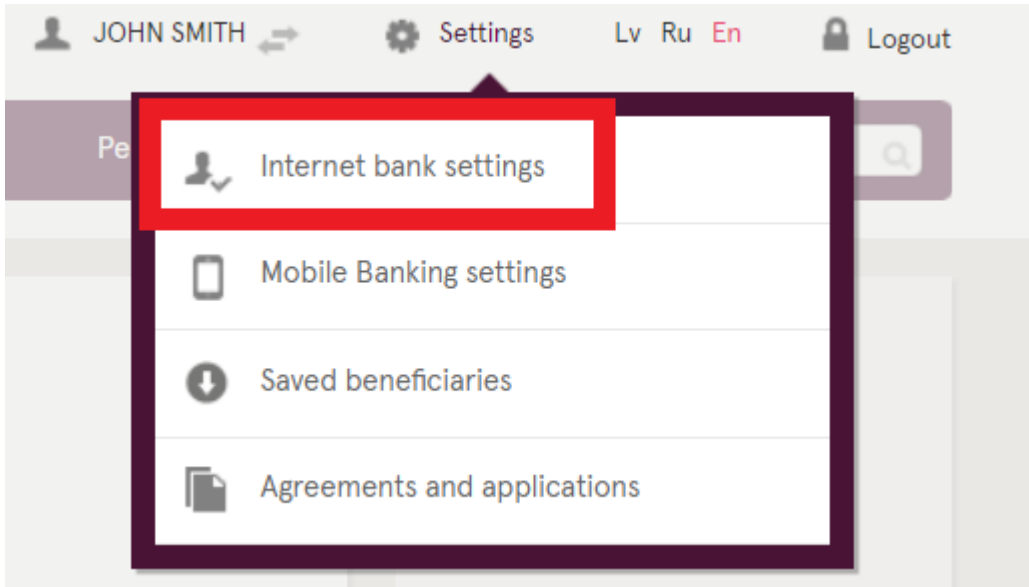

## How to update your consent on internet bank?

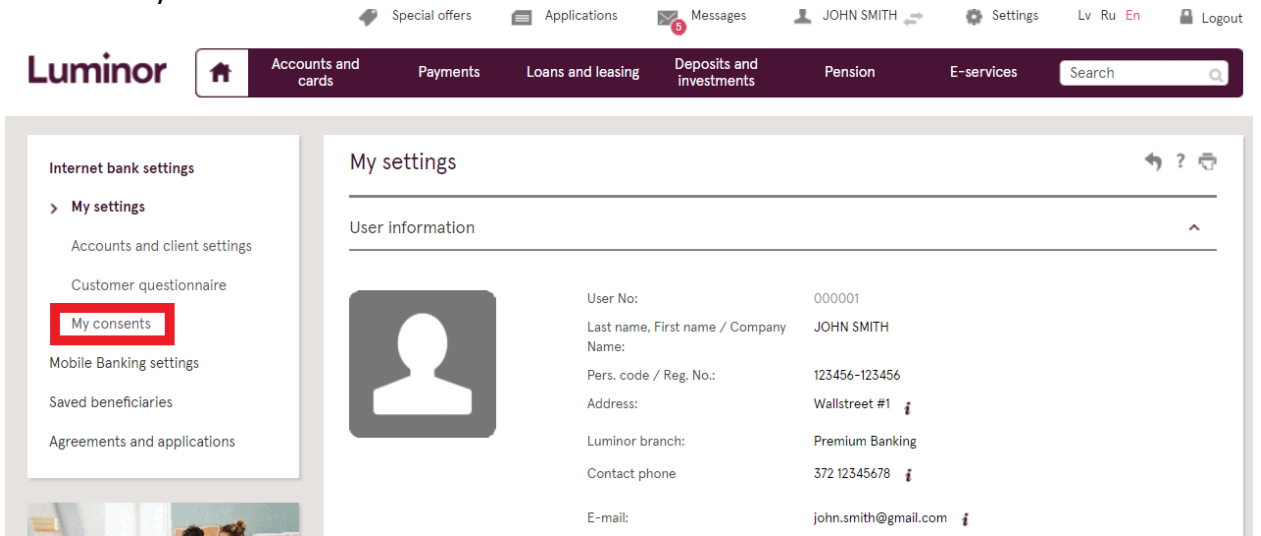
1. Log into internet bank and click on the “Settings” button:
