Fund description

This fund is mostly aimed at people born between 1982 – 1988. The most plausible proportion of investment in shares at the beginning is 90%. It starts to decrease when the standard participant reaches 16 years till the retirement age and is reduced by 5 percentage points each year until it reaches 10%. The proportion invested in investment-grade debt securities of the European Union, governments of countries of the Organisation for Economic Co-operation and Development, developing countries and non-investment-grade corporates is increased accordingly.

Fund manager's commentary

Second quarter proved to be even better in terms of performance mainly due to developed market equities. US market prevailed as the leader with most notable contributions from information technology, communications and consumer discretionary sectors. Even though both companies and investment analysts improved their earnings outlook for the near future, sentiment was the most important factor for returns. Rising equities were not discouraged by restrictive monetary policy. Due to rising interest rates government bond yields rose, especially in short term debt, which suppressed price appreciation.
